3. Particulars of any and all dispositions described in paragraph 25(a) of the notice made by Ontario since July 1, 1867.

4. Particulars of any and all transactions described in paragraph 25(c) of the notice made by Ontario since July 1, 1867.

5. Particulars of any and all failing to honour terms or conditions described in paragraph 25(d) of the notice by Ontario since July 1, 1867.

6. Particulars of any and all taking described in paragraph 25(e) of the notice by Ontario since July 1, 1867.

7. Particulars of any and all management of the Six Nations Trust described in paragraph 25(f) of the notice by Ontario since July 1, 1867.

8. Particulars of any and all failing to account described in paragraph 25(g) of the notice by Ontario since July 1, 1867.

9. Particulars of any and all statements, allegations or complaints by the Six Nations or any person on their behalf that Ontario has since July 1, 1867 committed any of the breaches alleged in the notice.
