The Defendant, the Attorney General of Canada, hereby requests full particulars of the allegations contained in the Statement of Claim as follows:

1. With respect to the allegations in paragraph 56, provide particulars of each transfer referred to, including the date of transfer and to whom the lands were transferred, and provide a copy of each transfer.

2. With respect to the allegations in paragraph 57, provide details of the consent of the Six Nations referred to, particularly, when did the Six Nations provide this consent, and if the consent is reduced to writing, provide a copy.

3. With respect to the allegations in paragraph 58.1, provide a copy of the consent of the Six Nations of March 22, 1830.

4. With respect to the allegations in paragraph 58.2, provide particulars of the circumstances relied on as showing or raising an inference of the Six Nations' understanding that surrender no. 31 was to reflect the Talbot Road Lands Surrender Proposal.

5. With respect to the allegations in paragraph 58.3, provide the document, if any, in which the Six Nations consented to the Talbot Road Lands Surrender Proposal.

6. With respect to the allegations in paragraph 58.5, provide a copy of the document dated September 28, 1831.

7. With respect to the allegations in paragraph 58.6, provide:

- (a) a copy of the public notice dated December 1, 1831;
- (b) particulars of each sale for all 100 and 200 acre lots, including the date of sale and the purchaser of each lot, and provide a copy of each sale; and
- (c) a copy of the document prepared by the selling agent

8. With respect to the allegations in paragraph 58.7, provide a copy of the document of November 25, 1831.

9. With respect to the allegations in paragraph 58.8, provide the specific date on which the Six Nations consented to the sale of part of the Talbot Road lands, and if the consent is reduced to writing, provide a copy.

10. With respect to the allegations in paragraph 58.10, provide particulars of each Disposition purporting to grant title or other interests to Third Parties in the Talbot Road and

the lands on either side of it, including the date of each Disposition and the specific Third Party that was granted title or other interests, and provide a copy of each Disposition.
