**THIS MOTION**, made by the plaintiff, Six Nations of the Grand River Band of Indians ("Six Nations") for directions regarding the date for compliance by the defendant, the Attorney General of Canada ("Canada") with this Court's order of July 27, 1999, following the dismissal by the Divisional Court on April 12, 2000 of an appeal of Canada from such order, was heard by telephone conference call on April 20, 2000, in the presence of counsel for the plaintiff, Six Nations and for the defendant, Canada respectively;

**UPON HEARING** submissions from counsel for each of the plaintiff and the defendant Canada, and this matter being reserved until this day,

1.           **THIS COURT ORDERS** that the defendant Canada comply with the

provisions of this Court's order of July 27, 1999, by no later than June 12, 2000, failing which the plaintiff may seek a sanction.

2. **THIS COURT FURTHER ORDERS** that in the event that a judge of the Court of Appeal stays some provisions of the order of July 27, 1999, the date for compliance by the defendant Canada with all other provisions will still be required by June 12, 2000, unless otherwise ordered by a judge of the Court of Appeal granting any stay, or a judge of the Court of Appeal granting leave to appeal, or by the Court of Appeal dismissing the appeal.

3. **THIS COURT ORDERS** that the costs of this motion for directions be in the cause.
