## CASE MANAGEMENT ENDORSEMENT

- [1] The 14th Case Management Conference was scheduled to continue on December 18, 2020 for the purpose of addressing a production issue raised by the Plaintiff regarding the additional documentary production made by the Attorney General for Canada ("Canada") on November 27, 2020: Six Nations of the Grand River Band of Indians v. The Attorney General of Canada, 2020 ONSC 7714, at paras. 11-14 (the "December 11 CM Endorsement").
- [2] The parties jointly reported today, by letter forwarded in accordance with paragraph 15 of the December 11 CM Endorsement, that Canada has secured an external contractor to assist in distinguishing between additional documents and duplicate documents amongst those produced by Canada on November 27, 2020. Canada anticipates that it will be able to characterize these documents and be in a position to provide a list to the Plaintiff and Her Majesty the Queen in Right of Ontario by January 8, 2021, provided that the work proceeds without complication.
- [3] On this basis, the parties advised that they do not currently require any modification to the Timetable, as set out in paragraphs 7-9 of the December 11 CM Endorsement.

- [4] As there are no other issues currently to address affecting the orderly development of this action, this 14<sup>th</sup> Case Management Conference, initiated on November 24, 2020 and continued on December 10, 2020, is now completed. Accordingly, the video conference scheduled for December 18, 2020 at 9:15 am is vacated, on the agreement of the parties.
- [5] The parties conferred and provided a list of dates convenient to them for the next Case Management Conference. Of those dates, I direct that the next Case Management Conference shall take place on January 13, 2021 at 9:15 am, by video conference, using video coordinates that will be provided by the Court.
- [6] I direct the parties to provide a Case Management Memorandum, even in the form of a letter, either individually or if in agreement, jointly, by 1:00 pm on January 12, 2021, setting out the issues that they seek to bring forward to the next Case Management Conference. This may be delivered to my judicial assistant, with copy to all parties.
- [7] Notwithstanding *Rule* 59.05, and in accordance with *Rules* 77.07(6) and 1.04, this order is effective from the date that it is made and is enforceable without any need for entry and filing, and without the necessity of a formal order.
